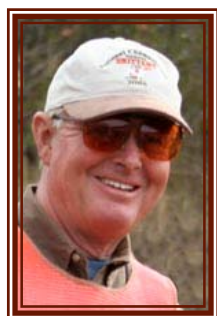

Here's a little piece that has nothing to do with our Brittanys ... but does have to do with good luck, and fun in the New Year!

Be careful What You Eat On New Year's Day!

Were you planning to eat chicken? If you do, you might end up scratching a living in the coming year just like a chicken scratching the ground. Forget those buffalo wings and think nachos or ripple chips and dip. We all know about resolutions but how much do we know about other beliefs, myths and legends that surround New Year's Day.

Damon Jones, Executive Chef at Larks restaurant in the Ashland Springs Hotel, is originally from Alabama. He said that Southerners firmly believe what is eaten on January 1 is worth more than all the good intentions in the world. AMERICAN BRITTANY RESCUE

2006 is Brittany Rescue's 15th anniversary. We'd rather be out of business altogether, but as long as Brittany's are being abandoned in shelters or owners call us saying they need to find a place for their dog to go, we'll be here.

In 2005 ABR handled almost 1000 dogs. About 150 of those were in California alone. Some of those were not Brittany's and were sent on to other rescue groups, some were let go due to health or temperament problems, but 760 purebred Brittany's were placed in new homes and at this writing 129 are still looking for homes.

This number grows every year. Part of the growth comes from increased exposure - as more people find out about rescue, more know where to call when they know about a Brittany in need. We get calls from individuals, shelters, vets and other rescue groups. But that simply can't account for all of the increase we see steadily each year. As Brittany lovers, breeders and people who work their dogs - people who are concerned about our breed, we all need to do what we can to help stem this increase in homeless, abandoned Brittany's.

People often contact rescue looking for a dog to breed to their wonderful dog. We appreciate how much their dog means to them and why they would think it is worthy of being bred. But this is an easy call for us. We simply tell them that no rescued dogs are placed intact! For others, that stud fee may look good. Or there may be a dog in the

kennel who is great - but she's just one too many. Please consider the lives that will be produced - does this "breeder" have the experience that a responsible breeder should have? are the genetic tests that should be done going to get done? will he take responsibility for the

lives produced for their entire lives? or will he consider that once the puppies are off his property they're not his concern any more? Please consider that if you make it possible for that litter to be bred, you are also responsible for the lives produced.

It's true that many of the dogs rescue receives are "backyard bred". But it's also true that almost every pedigree we see has a dog we recognize in the 2nd or 3rd generation...a puppy given to someone who bred it to "a great dog" and then had trouble getting rid of all the puppies produced. Most often, when we get a dog from a known breeder or even one whose grandparent was from a known breeder, we are gratified by the help that breeder gives us when they're contacted. But from these second generation breeders, we almost always hear, "it's not my problem" or "I already have 4 dogs, I can't take another one". Sometimes they're anxious to take the dog back until we tell them that we've spayed or neutered it - then they suddenly have no interest.

Education of the public on finding a responsible breeder and on what getting a Brittany puppy will mean

seems like the only logical answer. It's not an easy thing to do - and not one that seemed necessary when nobody knew what a Brittany was. But we all saw the increase in calls about puppies after the world saw a Brittany on TV at Westminster. As much as I enjoyed seeing a Brittany making a snow angel on TV, I was shocked by the number of people who recognized the breed!

More than ever, it seems incumbent on all of us who care about our breed to take any opportunity to tell people about the realities of living with a Brittany. Now that John Q Public knows about our breed, we need to be even more careful about how we place them. And now that the word is out about how great they are - we need to be more vigilant about making sure that potential puppy buyers know that they're NOT for everyone.

Rescue needs you! If you can take in a homeless dog, we'd love to have you; if you can help transport one to a foster home, we'd love to have you. But if the "only" thing you do is to be sure that you educate every puppy buyer and every potential Brittany owner you encounter - you will have done a lot to help rescue -- and our breed in general!
