



Field News from the First Vice-President

To: All Licensed Pointing Breed Hunting Test Clubs

Re: Multiple Hunting Test Titles

The Performance Events Department is seeking comments from Clubs and participants regarding the attached proposal meant to provide additional activities for participants in Pointing Breed Hunting Tests. The Hunting Test Program has been in existence for over 25 years. The pass/fail nature of the events and the graduated test levels have provided an enjoyable activity for owners and dogs with a wide variety of training and experience.

The Department has received many requests to provide additional activities for dogs that have earned Hunting Test titles. This proposal is meant to provide an incentive for owners to continue to enjoy the field experience with the dog at any level that they choose. The proposal folds into the existing program and creates no additional effort for host clubs.

Performance Events would like to hear your comments regarding the proposal to provide multiple titles. In addition, there is a related by separate suggestion at the bottom of the attachment regarding allowing dogs that have earned higher level titles to enter lower level tests strictly for the enjoyment of the dog and owner.

MULTIPLE POINTING BREED HUNTING TEST TITLES

Objective: Provide additional activities for dogs that have completed their JH, SH, or MH titles

General Description: A dog that has previously earned a Hunting Test title may continue to enter the same test level in an attempt to earn a numeric designation after the title. Five additional passing performances earns a dog a higher numeric designation. This may be done at any test level. For example, a dog may earn a JH2, SH2 or MH2 title.

Why This Approach? AKC receives numerous requests to provide additional activities for hunting test dogs. Many participants do not have the time or resources to work toward the higher test levels but still want to enjoy their dog by entering hunting tests even after earning their JH or SH title. For those that have achieved the MH title, recognition will be provided to dogs that maintain the Master level standard of performance. This approach will provide an incentive for owners at all levels to remain active with their dogs.

Title: After a dog has earned a hunting test title, if the dog earns five additional passing scores, a numeric designation will continue to be increased by one for every additional five passing performances (JH3, etc.). As is currently the case, a higher level hunting test will supersede the lower title. For example, a SH title will supersede a JH title regardless of the numeric designation on the JH title.

The owner is responsible to keep track of the dog's passing performances using a form developed by the Performance Events Department. Once five additional passing scores have been earned beyond the initial title, the completed form is mailed to the Department along with a title processing fee of \$20. Upon verification by the office staff, a number is placed behind the dog's existing title. The new title will be recorded on a dog's record (it will appear on pedigrees) and a title certificate is issued.

Feedback from owners regarding the need to keep track of passing performances indicates this is not an issue as most owners do this already. From the host club's point of view, this proposal will require no change to either the physical test itself or paperwork.

An Additional Change to the Regulations: Currently, the Regulations state that once a dog has earned a higher level title, the dog may not be entered in a lower level. There are cases where owners of older dogs would like to enter them in lower level tests simply because the dog enjoys the hunt but is no longer able to perform at the higher level. We would like to hear the thoughts of hosting clubs and participants regarding removing the restriction regarding entering a lower level. It should be noted that in this situation, the entry is strictly for the pleasure of the dog and owner since a dog will not be awarded a lower level title after it has earned one at a higher level.

Subject: SportDOG GPS Tracking Collar

The AKC Performance Events Department has approved the SportDOG GSP tracking collar for use in field trials and hunting tests. The model of this unit is TEK-V1L, which consists of the TEK-L collar and the TEK-H receiver. The GPS collar has an antenna that runs from the box below the dog's neck up around the side of the dog's head. The unit is pictured below.



This unit is unique in that there is an e-collar module that can be attached to the same collar. **The collar can not be used with the e-collar module attached.** The e-collar module has its own antenna; therefore this collar with the e-collar module attached will have two antennas, one on each side of the dog's head. Judges should be alert to the number of antennas. If there is any question or uncertainty, judges have the authority to request the collar be removed for inspection.

It is the responsibility of the handler to insure the dog is wearing an approved collar. If a handler errors, whether intentional or by mistake, it is the event committee's responsibility to investigate the matter and if in their opinion a violation of the regulations has occurred, the handler must be charged with misconduct.

The use of specific tracking devices may be rescinded at any time by the Performance Events Department if the regulations pertaining to their use become overly difficult to enforce or in the case of repeated misuse.

SOMETHING TO CHEW ON.....
