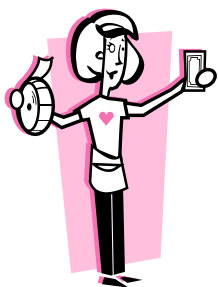

CBC ANNUAL AWARDS RULES

Eligibility:

Only Brittany's are eligible

Points may be earned in the following events:

American Kennel Club licensed shows, field trials, hunt tests, obedience trials and agility tests occurring in the Western region as laid out by the American Brittany Club.

American Brittany Club licensed events occurring in the Western region as laid out by the American Brittany Club.

The American Brittany Club Nationals. (National All Age, National Amateur All Age, National Gun Dog, National Amateur Gun Dog, National Specialty, National Summer Specialty and National Obedience trial.

American Field trials – Within the ABC Western Region (NSTRA trials are NOT included.)

Designated California Brittany Club events (Willi Match and Club Championship Fun trial).

The highest point total in each category determines the winner.

- The dog must be owned or co-owned by a member or associate member of the CBC, or a minor member of their immediate family.
- The point year runs from January 1 to December 31.
- It is the dog owner's responsibility to compile and submit a list of their dog's points to the club secretary. If there is a problem for any member finding the correct number of dogs defeated in any event, the club secretary is the official statistician and has the AKC results publication in which they can look up this information.

MAJOR AWARDS

Show Dog: The Show Dog Award will be determined by the highest total of dogs defeated in the show ring. Dogs and bitches can be awarded points if they place Reserve Winners or better. Futurity Show wins are counted in the same manner as regular show wins, 2nd money winner or better.

Example: Total Brittany's shown was 32; 10 class dogs, 11 class bitches, 7 male champions and 4 female champions.

Winners Dog gets 9 points (10 class dogs less self = 9)

Winners Bitch gets 10 points (11 class bitches less self = 10)

Reserve Winners Dog gets 8 points and Reserve Winners Bitch gets 9 points

Best of Winners if won by the Dog would add the Bitch entry to his 9 points giving him 20 points. If won by the Bitch she would add the Dog entry to her 10 points giving her 20 points. To those who win Best of Winners when the other class winner takes Best of Opposite Sex over Specials, be sure to add those specials defeated to your total.

Best of Opposite Sex if won by a Bitch Special gets 14 points (sum of all Bitch entries less self: $11 + 4 - 1 = 14$). If won by Dog Special, he gets 16 points (sum of all Dog entries less self: $10 + 7 - 1 = 16$). If won by Winners Dog, add the count of male specials to his point total. If won by Winners Bitch, add the count of bitch specials to her point total.

Best of Breed gets 31 points (sum of all Brittany's less self).

Group placements (1st thru 4th) get points for total entry of each breed defeated.

Field Dog: The Field Dog will be the highest scoring dog of either the All Age Dog or the Gun Dog. In the event that the dog competes in both categories the scores will be added together.

Dual Dog: The Dual Dog is required to compete and place in both the Field and the Show. At least one-third of the points must be earned in adult field stakes, one third in the show ring, and the remaining one third may be comprised of adult field or show wins or a combination of both.

Bonus points in the Dual Category: A finished show champion actively competing in the field may add 5 points (in the Dual Category only) for each show it was shown in. If the champion takes BOB or BOS the number of dogs defeated in this show OR the 5 points (whichever is greater) may be counted for the show – not both.

AWARDS

Field events: There will be three field events; All Age, Gun Dog, and Juvenile Dog (to include both Puppy and Derby placements). These events will be calculated as follows:

30 minute stakes – 1st through 4th place – Number of dogs defeated. (10 dog stake, 1st place defeated 9 dogs, 2nd place defeated 8 dogs, etc.)

Hour stakes – 1st through 4th place – Number of dogs defeated times 2 (10 dog stake, 1st place defeated 9 dogs times 2 = 18 points, 2nd place dog defeated 8 dogs times 2 = 16 points.)

Other Performance Events: There will be three performance awards; Obedience, Agility and Hunting Test.

The Obedience winner will be determined by taking the average of the three highest scores for the year. The dog with the highest average will be the winner. In case of a tie, the highest individual score will be the winner.

The Agility winner will be determined by adding up all of the qualifying scores and the number of seconds under standard time for those qualifying scores.

The Hunting Test winner will be determined by awarding points for each qualifying score as follows:

- A Junior Hunter earns 5 points for each qualifying score up to a maximum of 20 points in a year.
- A Senior Hunter earns 15 points for each qualifying score up to a maximum of 75 points in a year.
- A Master Hunter earns 50 points for each qualifying score with no maximum.

Junior Handler: There will be a Junior Handler award in both the field and the show categories.

The Show Junior Handler points will be tabulated on the number of handlers defeated in Junior Handler events.

The Field junior will be based on the points earned by the dog(s) handled and they will get a 5 point bonus for every event in which they participated.

Dual Junior Handler will be determined the same way that the Dual Dog is determined. One-third of the points must be earned in the field, one third in the show and the remaining third can be comprised of field points, show points or a combination of both.

Amateur Handled Dog: This award will go to the dog that earns the most points while being handled by an amateur in an adult field event.

Special Awards: When deemed appropriate a dog or person may receive an award for a particularly special accomplishment. (Examples – OTCH and MACH) This will be decided by a vote of the board of directors. Recommendations for a Special Award should be submitted to the president

Any dog earning a title during the year will also be recognized at the Awards Banquet.

This system of awards will become effective with the 2003 calendar year.

Deadline for submitting score sheets is June 15, 2012

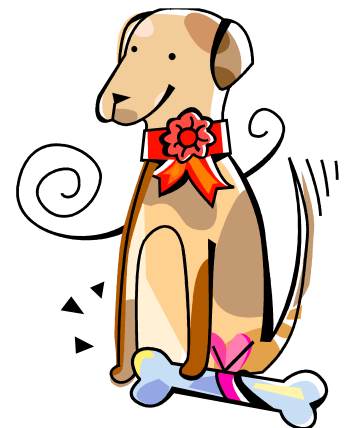
FROM THE HARDER HOUSE

Spring Field Trial

The CBC spring field trial was held at Castle Butte Wells on February 3-5, 2012. The weather was anything but predictable, which seems to be the norm in the Mojave Desert. The weather was dry, but fluctuated from warm with no wind, to cool and breezy. The event was a success because of the extra efforts of many individuals who contributed time and diligence to numerous tasks. Chairperson Mark Nunez and Secretary Karen Nelsen kept everything moving and on track. Several volunteers pitched in including bird planters Sheri Harder, Gregg Arney, Mark Ambre, Dan Doiron, and Mark Nunez ~ with the help of his "junior bird planters in training" (Kaitlyn & Sophia). The birds were purchased and transported to the event by all-around-utility-man Ed Dixon. A special thanks to all our judges, especially David Kirk (who took over the 36 dog OGD stake) and Cindy Leffingwell, who stepped in at the last minute to fill unexpected voids.

The trial was run utilizing the vast space in the desert, which included enough for three simultaneous courses. This trial was run with all stakes open to all breeds. The terrain provided ample opportunity for competitors to be in the right places and with game contact in nearly every brace, however temptation was too great for some. By the end of the weekend there were numerous coveys of bobwhite and chukar alike. The entry was generous enough that winners in juvenile stakes were awarded maximum points and adult stakes were all majors, including the 5 point major Open Gun dog stake. The club thanks the generous support from the Loyall pet food company providing bags of dog food for winners. Contestants and field trial attendees were also blessed with being able to schedule special viewings of Joe Gower's National Amateur Champion saddle, some were even lucky enough to hear Joe utter the words, "Have you seen my saddle?"

The spring fiesta began Friday evening with a catered dinner from Domingo's Restaurant of Boron. The lunches were prepared daily with the assistance of numerous camp volunteers, including Linda Dixon, Cindy Leffingwell and Peggy Doiron who was recovering from an ol' scouting injury. She will be glad to get back in the saddle soon! CHUKAR CHAMPIONSHIP

Editor's Note: The following article is excerpted from Leslie's full article which will appear in the ABC Magazine.

We were blessed in the weather department. For a Saskatchewan resident to be riding around in shirt sleeves in the afternoon on the last day of January was just what I was hoping for. It was cool in the mornings as the sun came up, even a bit of ice on the water bowls one day, but the days warmed quickly and made it to the mid 60's in the afternoons. A couple braces endured sudden high winds, which contributed to big running dogs not hearing as well as they should have, but most of the braces had very pleasant conditions to work with. Seventeen dogs competed in one hour heats.

Purina and TriTronics were official hosts of this championship. The support of these two companies means so much to the sport, and is appreciated by all the recipients of their quality products. An E-collar was donated by TriTronics to the winner, and bags of Pro Plan were awarded to all the winners.

The trial was supported by members of the California Brittany Club. Lois Mayhew got the day off to a good start by offering breakfast burritos, while Mark Nunez was the expert chef for the evening meals. No one went away hungry. The ground crew was made up of Peggy Doiron, Myra Dawn Ellis and Linda Dixon. Bird planters were Ed Dixon, Bill Leffingwell, Dan Doiron and Tom White. Margaret Horstmeyer was always busy with something, like taking me back and forth to the airport, picking up ribbons etc. I am sure I have missed someone who contributed to the smooth running of this trial, but know that your efforts were appreciated.

The first place dog came from the 7th brace in the form of a big liver and white dog, FC MVP Redline's High Octane, owned by Karen Nelsen and handled by Paul Doiron. "Tiger" as he is called, proved himself an all age dog with extreme range, drive and bird finding ability. He looked as good on point as he did on the ground, with three finds. The second place dog, DC MB's Make Mine A Double, also handled by Paul Doiron and owned by Bob Miller and Christine Landerholm-Miller, also gave a good account of himself with 4 very stylish finds and a good race in the first brace of the stake. Third place dog was DC/AFC Megasmoke Limited Edition, owned by Tom White and Margaret Horstmeyer, and handled by Tom. Ted had a find with great class and style, while running an all age race. An extended absence hurt his chances at a higher placement. A young dog named Kiger Hill's Louee, owned and handled by Ed Dixon, placed 4th. Louee had a very nice find and overall a good run for his hour and is one you will hear from in the future. It is interesting to note that the first three dogs placing were all sired by DC Redline's Tequila Smoker out of three different dams.

The Chukar Championship running order

Brace 1# MB's Make Mine A Double ("Mac") Doiron & In It For the Fun ("Dude") Hale

Breaking away at 8 a.m. the Chukar Championship got off to a great start. Mac scored 4 stellar finds with great style on all of them. He had a stop to flush also. His ground effort was consistent, smart and forward, handling quite kindly for Paul. At time he was found standing ---alas, without anything more than quail feathers to show for it. Dude started out slowly, but hunting hard. He scored a find along the right hand ridge in the early going. As he was sent forward after his find, he was acting birdy when a hawk swooped down and killed a chukar in his vicinity. Dude retrieved this bird to hand, but was not faulted for doing so. Dude moved out more in the middle of the hour, making some smart casts up into the hills. He was shortening again as the hour wrapped up.

Brace 2# Mikey's Spice Girl ("Spice") Doiron & Terra's Cabo Wabo ("Sammy")-White

Spice went to the right over the ridge at top speed and was not seen again under judgement. Sammy made a similiar move, but at 14 handler rode over a rocky ridge on course to find an intense pointing Sammy. A chukar flushed downhill with all manners in order. Sent on Sammy made a big cast to the biggest hill on the horizon. He was a fast white dot, but turned backwards at one point and needed scouting. He again hit out to the front, but was soon out of sight and again needed a lot of gathering to be put on the course. He finished the hour with impressive range, but his handling response remained on the rough side.

Brace 3# Kiger Hill's Louee ("Louee")-Dixon & MTB Can Am Formula Fun ("Frani") White

Louee scored a pretty find at 9. He made some beautiful moves along the ridges showing in the right places. He is a young dog, but handled well for his owner. It was heating up and his finish was not as good as it could have been. Frani was covering a lot of country. With a non-productive at 18 and increasing disregard for handling for her owner, she was picked up at 35 minutes.

Brace 4# HVK's High Flying Kyte-Doiron & MTB Cabo Rita de Scipio-White

Kyte showed us her heels as she sped to the front. She scored a very nice find before she disappeared from judgement. Rita was big off the breakaway, running the high country. She reappeared at about 7 minutes out, pointed briefly before taking out a running chukar to end her bid early.

Brace 5# Traveler's New Twist ("Trait") Doiron & Bluewater's Shady Pete-Down

Pete disappeared off the line and faded from sight. Wayne tried hard to produce him, but he ended up needing the tracker. Trait got to work quickly, with find after find; a smart bird dog doing what he was bred to do. He was getting a little more wound up as time went on, and needed to be rode for and put back on course at 35 minutes. With 6 finds to his credit, Trait disappeared to the front at 50, and would not be found in the grace period given him. We hated to lose him from the stake.

Brace 6# Red Sky Riley -Kirk and Spanish Corral's Sundance Kid ("Sonny") Gower

Riley started out like a house on fire, hitting the ridges and going hard to the right places. At 9, he scored a find with good manners. At 56, Riley pointed in a rocky crag, with no birds produced although there was evidence they had been there. The second half of his race was not nearly as strong as the first half hour. Sonny took to the flats out front and took a few minutes to straighten out his pattern. Once he did, he showed us why he was named National Amateur champion in 2011. He had high tight style on his first find at 17, duplicated the style on a second find, and added a third at 54, looking like a million dollars. His race seemed to get stronger the longer he was

down, and with the time almost expired on the clock, he disappeared over the final ridge not to be seen again under judgement, again given a generous grace period to show. Another one we hated to see get lost.

Brace 7# K Nine's Tocalota Chance ("Jim") Mayhew & MVP Redline's High Octane ("Tiger") Doiron
Jim is young and acted it when he pointed with style a few minutes out. He chased with enthusiasm to end his chances. Tiger was seen disappearing on the horizon, and next sighted on that big hill to the left at about 13 minutes out. (Thanks to Wayne Downs' sharp eyes for this sighting.) We watched him flow forward across the ridge and hit scent intensely for his first find at 15. All went well, and he was collared away to start over. Paul had barely got on his horse when Tiger stood tall again for his second find. Once turned loose, Tiger headed for the high country out front and drove hard at a breakneck pace. Paul gathered him to take to the water barrels at 33, with Tiger pointing another bird before they got there. Turned loose after watering, Tiger headed out strongly for the distant ridges. Spotted at great range, again by Wayne Down, Tiger then disappeared and was in danger of being counted out. Judges rode to the highest point we could find while scout and handler tried to produce dog. With only seconds left, Tiger appeared driving hard and looking like he could run another hour. He was the all age dog we were looking for.

Brace 8# Megasmoke Limited Edition ("Ted") White & Megasmoke Grand Finale ("Al") Doiron
The brace was called the battle of the brothers as one orange brother, Ted, fought it out with one liver brother, Al. Off the breakaway both had good range. Al was on the ridge early while Ted drove hard out front. Al scored first with a picture postcard find, perfect in every way. Ted countered with a beautiful piece of work at 15. Al added a second find, as nice as the first, with breathtaking style at 33. Both were running all age races. Ted was seen going hard to the front at 45 minutes. Al opted to disappear from judgement at this time. Ted was absent for a long time, and when returned, appeared very tired. After watering, Ted gamely punched to the front to finish his hour.

Brace 9# Tocalota's Running Reva-Mayhew

Reva ran by herself as a bitch in heat. She did not have her usual race, appearing to be more of a gun dog out for a leisurely hunt. She ended up birdless.

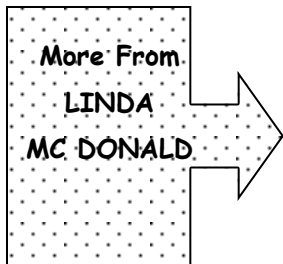

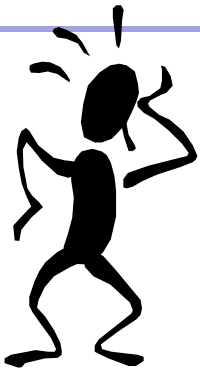

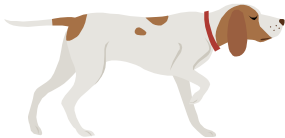
