Per our by-laws, the name of the person receiving the membership will require board approval. This is limited to current CBC members and new owners who will reside in the CBC membership area.
- Stand Alone Specialty Show 2015 Linda McDonald discussed the concerns of having a CBC stand alone specialty show in 2015. Areas of discussion included possible limited attendance, workers and financial pros and cons. Nancy Hensley made a motion to table the discussion for one year, second by Deborah Frane. Motion passed



ENTRY FEES: \$5 per dog. There will be no fee for Junior Showmanship, Veterans and Parade of Champion classes.


NOTE: Members are welcome to invite and recommend applicants for membership. Before the match commences the Board will consider the applications, so that those approved can participate.
