

Stakes will be run on two courses, without bird fields. A blank will be fired in all stakes except Puppy. Quail to be released in all stakes except puppy. Walking handling only in Amateur Gun Dog and Amateur Walking Derby, walking allowed in all stakes. AKC approved tracking collars will be permitted in all stakes, per AKC guidelines.
