#### PERFORMANCE BRITTANYS

I know there are Brittanys out there in obedience, rally, agility, FastCat, and other sports, but I'm not getting any news, so here goes another report on the scent work contingent.

The Scent Work Club of the San Gabriel Foothills held their two-day trial on July 12th and 13th at the Los Angeles Live Steamers Museum in Griffith Park. Entries were limited to 450, so you know it was a big deal. In spite of temperatures in the 90's, it was a great site for a trial, and we enjoyed big shade trees, a grassy park, and a pleasant breeze while we awaited our turns.

Saturday was a big day for Rowan (Oakhill It's About Time) as she qualified in all four of her odor classes, earning a first in Containers, a fourth in Exterior, fifth in Buried, and sixth in Interior. The best news of all was when they announced that Rowan was Advanced High in Trial!

On the same day, Nero qualified in Exterior, Container, and Buried, and placed third in Buried. On Sunday Rowan qualified in Exterior, and placed third in Interior. Rowan and Nero placed first and second, respectively, in Advanced Buried. Brittanys rule!

The following weekend Rowan headed to Moorpark, where she won the Interior and Buried classes on Saturday. She repeated the win in Interiors on Sunday and took second in Buried. She also completed her Interior Advanced Elite title, with her tenth qualifying leg. These were evening trials to avoid the heat, with the last searches happening in gathering darkness well after sunset. Talk about challenging! The dogs just continued to follow their noses, but the handlers definitely struggled.

August looks pretty quiet as far as Central Coast scent work, but we will ramp up again in the Fall. Meanwhile, Rowan is going to test her heeling skills in a rally/obedience match this month. Hopefully I can convince her that, unlike scent work where she gets to lead, she's supposed to follow my lead around the ring. We've been trying to negotiate this matter for 2 years now, and although I know Brittanys are known to be eager to please, I have a feeling she is still not ready to concede on this issue. If you never hear any results from this event, you'll know Rowan ruled the day (from her perspective at least) again.
