Entries will close when this number is reached, even if this occurs prior to the closing of entries. The Committee reserves the right to rearrange the running order of the stakes and add/rearrange judges if conditions warrant.

COURSES AND BIRDS

All Stakes will be run on single courses, **without** bird fields. A blank will be fired in all stakes except Open and Amateur Puppy. Quail and/or Chukar to be released in all stakes. Horseback handling is permitted in all open stakes. Amateur stakes are walking stakes. AKC approved tracking collars will be permitted in all stakes, per AKC guidelines.

Standard AKC ribbons will be awarded to all placed dogs.
Prizes will be awarded to all placed dogs in all stakes.
